

AN ORDINANCE OF THE MAYOR AND CITY COUNCIL AMENDING CHAPTER 2 OF THE CODE OF THE CITY OF CHANDLER, 1964, BY THE ADDITION THERETO OF ARTICLE XI AND SECTIONS THEREUNDER, PROVIDING FOR THE ESTABLISHMENT OF A PARKS AND RECREATION ADVISORY BOARD.

BE IT ORDAINED by the Mayor and City Council of the City of Chandler:

SECTION I. Chapter 2 of the Code of the City of Chandler, 1964 is hereby amended by the addition of Article XI and Sections thereunder:

"Article XI. Parks and Recreation Advisory Board"

Section 2-60. Establishment

There is hereby established a Parks and Recreation Advisory Board. The Board shall be composed of seven (7) regular members and a student from each High School located within the Corporate limits of the City. The seven (7) regular members shall be appointed by the Mayor, subject to the approval of the City Council. Student members shall be recommended by the Student Council, approved by the High School Principal and appointed by the Mayor, subject to the approval of the City Council.

Section 2-61. Terms of Office

The terms of office for the regular members of the Board shall be for three years, except that the first members of the Board shall be appointed for the following terms: Two members shall serve for one year; Two members shall serve for two years; and three members shall serve for three years. Thereafter, their successors shall serve a full term.

Student members shall be appointed to a term of one year. All members shall serve until their successors have been duly appointed and qualified. A vacancy in office during a term shall be filled in the manner as the original appointment.

This section shall be retroactive in effect from May 1, 1970.

Section 2-62. Officers

The Board shall elect its own officers at the first meeting following the 1st of May of each year. The Parks and Recreation Director, or his duly authorized representative, shall act as Secretary of the Board but shall not be allowed to vote. No officer elected by the Board shall serve in the same capacity for more than two consecutive one-year terms.

Section 2-63. Powers and Duties Generally

The powers and duties of the Parks and Recreation Advisory Board shall be:

- a) to adopt such rules of procedure for the faithful performance of its duties.
- b) to provide that five (5) members shall constitute a quorum and that the affirmative vote of the majority of members present shall be required for passage of any matter before the Board.
- c) to assist and advise the Parks and Recreation Director of essential policies, rules and regulations relating to the operation, use, care and maintenance of areas and structures owned, leased or otherwise acquired by the City of Chandler for use as parks and recreational centers.
- d) to assist and advise the Planning Commission in the planning, acquisition and disposition of parklands and recreational areas owned, leased or otherwise acquired by the City of Chandler.

- e) to assist and advise the Parks and Recreation Director in the development of a continuing plan for the City's park system and its recreation program. The City Manager, through the Parks and Recreation Director, shall, from time to time, send such plans and programs to the Board for its review. The results of such reviews shall be forwarded to the City Council through the Planning Commission.
- f) to assist and advise the Parks and Recreation Director in establishing priorities at budget time for those items, other than administrative functions, relating to park development and recreation programs. The recommendations of the Board shall be forwarded to the City Council by the City Manager when he submits the tentative budget to the Council.
- g) all recommendations relating to site acquisition and park planning will first be forwarded to the Planning Commission for its review.
- h) to receive, accept and acquire, subject to the recommendation of the Planning Commission and final action by the City Council, by gift, bequest or devise real and personal property of every kind, nature and description in the name of the City of Chandler, for park and recreational purposes subject to the terms of the gift.
- i) to recommend to the City Council for appointment the creation and membership of committees that are deemed helpful to the parks and recreation program.
- j) to suggest to the Mayor and City Council qualified and interested person (s) eligible for appointment for Board vacancies.

SECTION II. General qualifications of members, expiration date of terms of office, grounds for removal of members, forfeiture of office shall be in accord with Article X, Chapter 2 of this Code.
