AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF CHANDLER, AMENDING CHAPTER 2A OF THE CHANDLER CITY CODE RELATING TO THE AIRPORT AUTHORITY BY ITS REDESIGNATION TO AIRPORT COMMISSION AND DELINEATION OF ITS ORGANIZATION, FUNCTIONS AND RESPONSIBILITIES.

BE IT ORDAINED by the Mayor and Council of the City of Chandler, Arizona, as follows:

Section I. Chapter 2A of the Chandler City Code is hereby amended to read as follows:

"Chapter 2A. Chandler Airport Commission.

Section 2A-1. Establishment; Members; Terms. There is hereby established a Commission to be known as the 'Chandler Airport Commission', consisting of five (5) members appointed by the Mayor with the approval of the Council. In addition, the Mayor shall appoint a Councilmember as an ex-officio member to serve as liaison between the Commission and the Council.

The term of each member shall be for three (3) years and the members appointed by the Mayor to the Airport Authority shall be deemed to be appointed to the Airport Commission. Each member shall serve until his successor is appointed.

Section 2A-2. Officers; Meetings; Administration of Oath and Compelling Attendance of Witnesses; Quorum.

The regular Commission members shall elect a chairman and vice-chairman from among their number. All meetings of the Commission shall be public and shall be regularly held and special meetings may be held at the call of the chairman and at such other times as the Commission may determine. The Commission shall establish the time and date of its meetings through rules and regulations as hereinafter permitted. The chairman or, in his absence, the vice-chairman, may administer oaths and compel the attendance of witnesses. The Airport Manager shall be secretary to the Commission and a recording secretary to the Commission shall be appointed by the City Manager. A majority of the regular Commission members shall constitute a quorum at any meet-

Section 2A-3. Rules, Regulations and Records. The Commission shall have power to make and publish rules and regulations with the approval of the Council to govern its proceedings and to carry into effect the provisions of this Code. The recording secretary shall keep minutes of the proceedings showing the vote upon every question, or if a member is absent or fails to vote, indicating that fact and shall keep records of the Commission's examinations and other official actions. Minutes of the Commission shall be filed forthwith in the Office of the Airport Manager and in the Office of the City Clerk and the same shall be a public record.

Section 2A-4. Powers and Duties.

 To recommend and make suggestions to the Council and all other public authorities, plans for the regulations of the future growth, development and beautification of the Chandler Municipal Airport and its immediate environs.

To review and recommend to the Council proposed land use relating to leases and

fixed base operations.

3. To recommend and make suggestions to the Council on establishment of policy governing airport operations, rates and fees to be charged all users of the airport and regarding the annual budget.

4. To do, exercise and perform any and all such other powers and duties as may be assigned to it by the City Council or given to it under any law of the State or Code of this City."

Section II. Sections 2A-5 through 2A-21 are hereby repealed and are reserved for future legislation.
