**RECOMMENDATION**

Staff recommends Council forward a recommendation for approval of a Special Event Liquor License for the Downtown Chandler Community Foundation that approval be given for the City of Chandler Special Event Liquor License.

**DISCUSSION**

An application for a Special Event Liquor License has been submitted by the Downtown Chandler Community Foundation for the 8th Annual Classic Car & Hot Rod Show on Saturday, February 26, 2011 from 10:00 a.m. until 4:00 p.m. at Dr. AJ Chandler Park, 3 S. Arizona Ave.

With a Special Event Liquor License the organization can sell all alcoholic beverages within the confines of the event during the designated event periods.

The Police Department reports no objections to the issuance of this license. As this applicant is a non-profit organization, no sales tax license is required; however, the special event liquor fee has been paid.




