**SUBJECT:** REQUEST TO ADD SAMPLING PRIVILEGES FOR A SERIES 9 LIQUOR STORE LIQUOR LICENSE FOR 101 LIQUOR SQUARE LLC, DBA LIQUOR SQUARE

**RECOMMENDATION**

Staff recommends Council forward a recommendation for approval to add sampling privileges to the existing State Liquor License No. 09070487s, and further, that approval be given to add sampling privileges to the City of Chandler Series 9, Liquor Store Liquor License No. 50870 L09, for 101 Liquor Square LLC, dba Liquor Square located at 3029 N. Alma School Rd.

**BACKGROUND**

The 101 Liquor Square LLC, dba Liquor Square has been in business at this location since May 1, 2004, at which time Council approved a Series 9, Liquor Store Liquor License. The applicant has submitted an application to add sampling privileges to their Series 9 State Liquor License No. 09070487s. The Arizona State Legislature amended A.R.S. Section 4-206.01(J) effective July 29, 2010, allowing an applicant or licensee of a Liquor Store Liquor License to apply for sampling privileges.

**DISCUSSION**

The following application to add sampling privileges to the existing liquor license has been posted for hearing on February 24, 2011:

Series 9, Liquor Store Liquor License, for 101 Liquor Square LLC, dba Liquor Square located at 3029 N. Alma School Road.

All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 9, Liquor Store Liquor License the business may sell all alcoholic beverages for off-premise consumption only.

**PROPOSED MOTION**

Move for recommendation to the State Department of Liquor Licenses and Control for approval to add sampling privileges to the existing State Liquor License No. 09070487s, for 101 Liquor Square LLC, dba Liquor Square located at 3029 N.
