ORDINANCE NO. 4281

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CHANDLER, ARIZONA, TO AUTHORIZE AND APPROVE GRANTING A NO COST SIX (6) FOOT WIDE EASEMENT FOR A GAS LINE TO SOUTHWEST GAS CORPORATION TO RELOCATE ONE OF ITS GAS LINES LOCATED NEAR THE NORTHEAST CORNER OF ALMA SCHOOL ROAD AND RAY ROAD.

WHEREAS, the City of Chandler owns several parcels of land located at the northeast corner of Alma School Road and Ray Road that have an existing 6 foot wide Utility Easement for a gas line dividing said parcels; and

WHEREAS, Southwest Gas Corporation is willing to relocate said gas line at no cost to the City; and

WHEREAS, once the gas line has been relocated into a new easement Southwest Gas Corporation will abandon the portion of its existing easement that divides the City owned parcels; and

WHEREAS, the relocation of said gas line will benefit the City, the Public and the future development of said parcels; and

WHEREAS, the City of Chandler is willing to grant a 6 foot wide easement for a gas line to Southwest Gas Corporation, at no cost, to allow for the relocation of the existing gas line at this location.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Chandler, Arizona, as follows:

Section 1. That the City Council of the City of Chandler, Arizona authorizes and approves the granting of a 6 foot wide easement for a gas line to Southwest Gas Corporation through, over, under and across that certain property described and depicted in Exhibits "A" and "B" attached hereto and made a part hereof by this reference.

Section 2. That the granting of said easement shall be in a form approved by the City Attorney.

Section 3. That the Mayor of the City of Chandler, Arizona, is hereby authorized to execute the easement document and this Ordinance on behalf of the City.

For and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, receipt of which is hereby acknowledged, the undersigned, hereinafter referred to as Grantor(s), does hereby grant, convey, quitclaim and release unto <b>SOUTHWEST GAS CORPORATION</b> , a California Corporation, its successors and assigns hereinafter referred to as Grantee, a perpetual easement <u>6.0</u> feet wide for the installation and maintenance of a natural gas pipeline or pipelines and appurtenances, across, over, under and through the following described property, to wit: SEE ATTACHED EXHIBIT(s)			
together with the right of ingress and egress to and from the said easement and the right to use existing roads for the purpose of constructing, inspecting, repairing, and maintaining said pipeline or pipelines and appurtenances and the removal or replacement of same, in whole or in part, at will.			
Grantor agrees that no buildings, structures, fences or trees shall be placed upon, over or under said parcel of land, except for street, road or driveway purposes, which Grantor agrees shall not interfere with Grantee's exercise of the rights herein granted. Grantee agrees to work with due care in the exercise of its rights on the property and to restore it to reasonably the same condition which existed before the work was performed.			
Except as provided above, Grantee agrees to pay all direct damages which are caused by the Grantee's exercise of the rights herein granted.
