**SUBJECT:** NEW LICENSE SERIES 12 RESTAURANT LIQUOR LICENSE APPLICATION FOR LAUREN KAY MERRETT, AGENT, ANO LLC, DBA CYPRUS GRILL

**RECOMMENDATION**

Staff recommends Council forward a recommendation for approval of State Liquor License No. 12078702, and further that approval be given for the City of Chandler Series 12, Restaurant Liquor License No. 134746 L12, for Lauren Kay Merrett, Agent, Ano LLC, dba Cyprus Grill located at 1065 W. Queen Creek Road, Ste. 2.

**DISCUSSION**

The following application for a liquor license was posted for hearing on May 12, 2011, at which time it was continued until June 23, 2011:

New License, Series 12, Restaurant Liquor License, for Lauren Kay Merrett, Agent, Ano LLC, dba Cyprus Grill located at 1065 W. Queen Creek Road, Ste. 2.

**Consideration may be given to the applicant’s personal qualifications and to the location.**

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 12, Restaurant Liquor License, the business may sell all liquors for on-premise consumption only, with a minimum of 40% of the gross receipts from the sale of food.

The applicant’s Use Permit through Transportation and Development is also scheduled for this meeting.




