5. SUBJECT: Approve Amendment 1 to increase Agreement WW1-914-2899 for Plumbing Service to Roto Rooter Service and Plumbing Company, Cartright's Drain Service, and Reddi Services Inc. in an amount not to exceed \$400,000.

6. RECOMMENDATION: Recommend approval of Amendment 1 to increase Agreement WW1-914-2899 for Plumbing Service to Roto Rooter Service and Plumbing Company, Cartright's Drain Service, and Reddi Services Inc. in an amount not to exceed \$400,000.

7. HISTORICAL BACKGROUND/DISCUSSION: Wastewater Collections maintains and repairs all City-owned sewer mains including crushed or damaged sewer laterals from the main through the public right-of-way. Wastewater Collections averages 72 sewer service repairs annually.

In most situations, the most cost effective way to repair lateral and main lines is to engage a plumbing contractor. Within 48 hours of notification, the contractor excavates the area, repairs the damaged line, and restores landscaping to its original state. Staff received additional work requests and a funding increase is necessary to address them.

8. EVALUATION PROCESS: On October 28, 2010, Council approved agreements to Roto Rooter Service and Plumbing Company, Cartright's Drain Service, and Reddi Services Inc. for Plumbing Service in the amount of \$200,000.
