**7. HISTORICAL BACKGROUND/DISCUSSION:** This contract provides for rental and laundering of uniforms as well as entrance and hall mats, shop/print towels and lab coats. The Departments with employees utilizing the uniform rental and laundry service are: Municipal Utilities, Transportation and Development, Community Services, Airport, Housing, Police, Fire and Management Services.

**8. EVALUATION PROCESS:** In August 2009, Council awarded a two-year agreement for uniform/clothing rental and laundry services. Unifirst has agreed to extend the agreement for the first of three additional one-year periods with no price increase. Staff is satisfied with the service and recommends extending.

**9. FINANCIAL IMPLICATIONS:** Funds for uniform rental and laundry services are available in each user department's accounts.





NOW THEREFORE, the parties agree as follows:


1. This contract is extended for a one-year period, September 1, 2011 through August 31, 2012.


