5. SUBJECT: Amendment 1 extending Agreement SW0-926-2873 for collection of usable items with Stardust Building Supplies, Habitat for Humanity, Swift Charities for Children, Catholic Charities Community Services, and Big Brothers Big Sisters of Central Arizona.

6. RECOMMENDATION: Recommend approval of Amendment 1 extending Agreement SW0-926-2873 for collection of usable items with Stardust Building Supplies, Habitat for Humanity, Swift Charities for Children, Catholic Charities Community Services, and Big Brothers Big Sisters of Central Arizona.

7. HISTORICAL BACKGROUND/DISCUSSION: In 2007 a comprehensive waste characterization study identified materials in the solid waste stream that have recycling and reuse value. Information from this study suggested ways to achieve the City's goal of reducing waste through recycling and reuse.

In 2009, staff looked at ways to divert goods self-hauled by residents to the Recycling-Solid Waste Collection Center. The reusable goods include gently used items of clothing, furniture, toys, small working appliances, exercise equipment, and household decorative items

In 2010, the City contracted with five non-profit organizations that assist those in need with varying services. The City increased diversion of usable items by 12 tons, keeping reusable goods out of the landfill and reducing costs associated with disposal. Although no additional charitable organizations are partnered with the City at this time, this program remains opportunistic to include other non-profit organizations in the future.

8 EVALUATION PROCESS: On May 17, 2010 the City issued a Request For Information (RFI) to determine interest in participating in a reuse program. The RFI was advertised, sent to all registered bidders, and to firms the City believed showed interest in participating. Staff is pleased with the services provided and recommends an extension of Agreement SW0-926-2873.

9. FINANCIAL IMPLICATIONS:

Cost: N/A

Savings: Cost savings approximately \$440, with about 12 tons of reusable items diverted from landfill disposal.

Long Term Cost: N/A

10. PROPOSED MOTION: Move to approve Amendment 1 extending Agreement SW0-926-2873 for collection of usable items with Stardust Building Supplies, Habitat for Humanity, Swift Charities for Children, Catholic Charities Community Services and Big Brothers Big Sisters of Central Arizona, and authorize staff to enter into agreements with additional non-profit corporations and revise categories of materials collected.


