RECOMMENDATION

Staff recommends Council forward a recommendation for approval of State Liquor License No. 06070246, and further, that approval be given for the City of Chandler Series 6, Bar Liquor License No. 125138 L06, for Destiny Yvonne Myres, Agent, Straight No Chaser LLC, dba Nate's Third Base, located at 1949 W. Ray Rd., Suites 11-13.

DISCUSSION

The following application for a liquor license was posted for hearing on September 22, 2011, where it was continued until October 27, 2011, at which time it was continued again until November 17, 2011:

New License, Series 6, Bar Liquor License, for Destiny Yvonne Myres, Agent, Straight No Chaser LLC, dba Nate's Third Base, located at 1949 W. Ray Rd., Suites 11-13.

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 6, Bar Liquor License, the business may sell all alcoholic beverages for on- or off-premise consumption.

The applicant's Use Permit through Transportation and Development is also scheduled for this meeting.



This map shows the locations of all churches, schools and spirituous liquor outlets within a one (1) mile radius of the proposed location.




