

ORDINANCE NO. 4327

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CHANDLER, ARIZONA, TO AUTHORIZE AND APPROVE THE DEDICATION IN FEE OF PORTIONS OF CITY-OWNED MUNICIPAL UTILITIES PROPERTY FOR PUBLIC ROADWAY, AT THE SOUTHWEST CORNER OF GILBERT ROAD AND OCOTILLO ROAD, CHANDLER, ARIZONA.

WHEREAS, the City of Chandler owns vacant property located at the Southwest Corner of Gilbert Road and Ocotillo Road; and

WHEREAS, Gilbert Road and Ocotillo Road will be widened and improved as part of the Gilbert Road Improvement Project from Queen Creek Road to Hunt Highway ST-0809; and

WHEREAS, portions of the property are needed to be dedicated in trust to the public for public roadway; and

WHEREAS, it is necessary for Council to authorize the dedication in fee of the public roadway adjacent to the City-owned properties.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Chandler, Arizona, as follows:

Section 1. That the City Council of the City of Chandler, Arizona authorizes and approves the dedication in fee of portions of City-owned property for public roadway as described and depicted in Exhibit "A" attached hereto and made a part hereof by this reference.

Section 2. That the approval of the dedication shall not become final until a deed granting the right-of-way to the Public in trust has been recorded by the City Clerk.

Section 3. That the deed shall be in a form approved by the City Attorney.

Section 4. All dedications shall be subject to existing liens, easements or other encumbrances of record existing at the time the dedication is completed.

Section 5. That the Mayor of the City of Chandler, Arizona, is hereby authorized to sign of behalf of the City, all documents required and necessary to complete the dedications including signing this Ordinance.

**LEGAL DESCRIPTION
FOR
PARCEL NO. 303-44-003-C
GILBERT ROAD-QUEEN CREEK ROAD TO HUNT HIGHWAY
RIGHT-OF-WAY**

That portion of a parcel of land as described in Document # 2006-0585055, records of MARICOPA COUNTY, ARIZONA located in the NORTHEAST QUARTER of SECTION 24, TOWNSHIP 2 SOUTH, RANGE 5 EAST of the Gila and Salt River Base and Meridian, Maricopa County, Arizona, being more particularly described as follows:

COMMENCING at the SOUTHEAST CORNER OF SAID SECTION 24, being monumented with a Brass Cap in handhole, from which the SOUTH QUARTER CORNER of SAID SECTION 24, being monumented with a Brass Cap in handhole, bears South 89 degrees 16 minutes 29 seconds West a distance of 2628.60 feet, said line being the South line of the Southeast Quarter of Section 24 and the basis of bearings for this description;

Thence along the East line of the Southeast Quarter of Section 24, North 00 degrees 16 minutes 50 seconds West a distance of 2650.04 feet to the calculated position for the East Quarter corner of said Section 24;

Thence along the East line of said Northeast Quarter of Section 24, North 00 degrees 18 minutes 16 seconds West a distance of 2647.87 feet to the Northeast Corner of said Section 24, being monumented with a PK nail and straddlers;

Thence returning along said East line of the Northeast Quarter, South 00 degrees 18 minutes 16 seconds East a distance of 33.00 feet to a point on the Easterly prolongation of the existing South right of way line of Ocotillo Road;

Thence along said easterly prolongation, South 89 degrees 07 minutes 37 seconds West a distance of 33.00 feet to a point on the existing West right of way line of Gilbert Road, said point being the POINT OF BEGINNING;

Thence along said existing West right of way line of Gilbert Road, South 00 degrees 18 minutes 16 seconds East a distance of 1239.05 feet to a point on the Northwesternly line of that certain parcel described as Parcel No. C in deed to Roosevelt Water Conservation District recorded as Document # 1995-0512370;

Thence along said Northwesternly line, South 89 degrees 12 minutes 44 seconds West a distance of 3.93 feet to the beginning of a tangent curve concave Southerly and having a radius of 75.00 feet;

Thence Southwesterly along said curve, through a central angle of 20 degrees 04 minutes 53 seconds an arc length of 26.29 feet to a point on a non-tangent curve concave Easterly and having a radius bearing North 86 degrees 48 minutes 57 seconds East a distance of 1865.00 feet;

Thence Northerly along said curve through a central angle of 02 degrees 52 minutes 47 seconds an arc length of 93.73 feet to a point of tangency with a line parallel with and 65.00 feet Westerly, measured at right angles, from said East line of the Northeast Quarter of said Section 24;

Thence along said parallel line, North 00 degrees 18 minutes 16 seconds West a distance of 917.55 feet to a point;

Thence South 89 degrees 41 minutes 44 seconds West a distance of 10.00 feet to a line parallel with and 75.00 feet Westerly, measured at right angles, from said East line of the Northeast Quarter of said Section 24;

Thence along last-mentioned parallel line, North 00 degrees 18 minutes 16 seconds West a distance of 180.30 feet to a point;

Thence North 45 degrees 43 minutes 55 seconds West a distance of 28.08 feet to a point on a line parallel with and 65.00 feet Southerly, measured at right angles, from the North line of said Northeast Quarter of Section 24;

Thence along last-mentioned parallel line, South 89 degrees 07 minutes 37 seconds West a distance of 404.35 feet;

Thence North 00 degrees 52 minutes 23 seconds West a distance of 32.00 feet to a point on a line parallel with and 33.00 feet Southerly, measured at right angles, from said North line of the Northeast Quarter of Section 24, said parallel line being the existing South right-of-way line of Ocotillo Road;

Thence along said existing South right of way line of Ocotillo Road, North 89 degrees 07 minutes 37 seconds East a distance of 466.67 feet to the POINT OF BEGINNING.

Containing an area of 55,730 SQUARE FEET or 1.279 ACRES, more or less.


