RECOMMENDATION

Alma School Rd.

With a Special Event Liquor License the organization can sell all alcoholic beverages within the confines of the event during the designated event periods.

The Police Department has no objections to this event, and the applicant has applied for a Temporary Sales and Promotional Event Permit through Neighborhood Resources.


