RECOMMENDATION

Staff recommends Council forward a recommendation for approval of State Liquor License No. 12079103, and further, that approval be given for the City of Chandler Series 12, Restaurant Liquor License, No. 139164 L12, for Theresa June Morse, Agent, Valley Smokers LLC, dba Can't Stop Smokin' Bar-B-Q, located at 7250 W. Chandler Blvd.

DISCUSSION

The following application for a liquor license was posted for hearing on May 24, 2012:

New License, Series 12, Restaurant Liquor License, for Theresa June Morse, Agent, Valley Smokers LLC, dba Can't Stop Smokin' Bar-B-Q, located at 7250 W. Chandler Blvd.

Consideration may be given to the applicant's personal qualifications and to the location.

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 12, Restaurant Liquor License, the business may sell all liquors for on-premise consumption, with a minimum of 40% of the gross receipts from the sale of food.

The applicant's Use Permit through Transportation and Development was previously approved at the April 26, 2012 Council Meeting.

PROPOSED MOTION


