SUBJECT: Amendment No. 2 to extend agreement FS0-060-2752 for Original Equipment Manufacturer (OEM) parts and service to Balar Equipment, Earnhardt Ford Sales Company, Earnhardt Chrysler Jeep Dodge, Earnhardt Toyota Scion, PSS/First In, H and E Equipment, RWC International and Norwood Equipment in an amount not to exceed \$250,000.

6. RECOMMENDATION: Recommend Amendment No. 2 to extend agreement FS0-060-2752 for OEM parts and service to Balar Equipment, Earnhardt Ford Sales Company, Earnhardt Chrysler Jeep Dodge, Earnhardt Toyota Scion, PSS/First In, H and E Equipment, RWC International and Norwood Equipment in an amount not to exceed \$250,000.

7. HISTORICAL BACKGROUND/DISCUSSION: The City's Fire Department has an ongoing requirement to repair all City of Chandler vehicles and service equipment. The requested contracts will provide OEM parts and service. The primary use of the contracts will be to purchase repair parts. Staff may use the service component of the contracts on a very limited basis.

8. EVALUATION PROCESS: In November of 2009 the City awarded an RFP for OEM parts and service for all the manufacturers of equipment in the City's fleet. The contract was awarded for two years with provisions to extend for three additional years. All contractors have agreed to the second extension at the same terms.
