**RECOMMENDATION**

Staff recommends Council forward a recommendation for approval of State Liquor License No. 01073034, and further, that approval be given for the City of Chandler Series 1, In State Producers Liquor License No. 143771 L1, for Anthony Canecchia, Agent, San Tan Brewing Company Inc., dba San Tan Brewing Company, located at 495 E. Warner Road.

**DISCUSSION**

The following application for a liquor license was posted for hearing on November 8, 2012, at which time it was continued until December 13, 2012:

New License, Series 1, In State Producers Liquor License for Anthony Canecchia, Agent, San Tan Brewing Company Inc., dba San Tan Brewing Company, located at 495 E. Warner Road.


The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 1, In State Producers Liquor License, the business may manufacture and produce spiritous liquors and sell the product to a licensed wholesaler. On premise consumption is allowed for free samples and for sale in conjunction with a Series 6, 7, or 12 license.

The applicant's Use Permit through Transportation and Development is also scheduled for this meeting.




