5. SUBJECT: Purchase of police vehicles.

6. RECOMMENDATION: Recommend approval to use the State of Arizona contract for the purchase of police vehicles from Midway Chevrolet in an amount of \$203,445.96.

7. HISTORICAL BACKGROUND/DISCUSSION: The Police Department submitted vehicles to be evaluated for funding in FY 12/13. The City's Fleet Advisory Committee reviews mileage, years of service, reliability, repair history and forecasted ability to meet service requirements. The Fleet Advisory Committee reviewed the vehicles submitted by the Police Department and the committee recommends the replacement of five (5) Chevrolet Tahoes PPV SUV's for the Police Department. The requested vehicles are Chevrolet Tahoe PPV SUV's with up-fitting including three equipped for patrol, one for supervisor and one equipped for DUI. The requested DUI equipped vehicle is not part of the Vehicle Replacement Program and is being purchased with grant funds.

8. EVALUATION PROCESS: Historically the City has used the State of Arizona contract to purchase vehicles. At the direction of City Council, staff has issued bids for recent vehicle purchases. Price comparisons of recent bids have generally indicated that if the State contract has been recently bid it has better pricing then the Chandler bid. The recommended contract was awarded January of 2013. Therefore, staff is recommending use of State contract for this purchase.




