



Residential childcare is permitted in single-family residences as an accessory use to the primary residence allowing up to 4 children for compensation. A Use Permit is required for at least 5 up to a maximum of 10 children for compensation. In May 2002, the subject site was granted a Use Permit for 5 years to operate a residential childcare use. The Use Permit expired in May 2007. A Use Permit time extension was granted in September 2007 for an additional 5 years. The business maintains a State licensing as a childcare group home. The request is to approve the Use Permit with no time limit and continue having up to 10 students for compensation.

The single-family home is approximately 2,169 square feet. The property owner resides in the home while also running a childcare school business. The childcare school is open Tuesday thru Friday 8:00 a.m. to 3:30 p.m. and follows the local school district calendar. There is no childcare or schooling Monday, Saturday, or Sunday. The majority of children attend the full day school from 8:00 a.m. to 3:30 p.m. However, there are two other sessions offered from 8:00 a.m. to 12 p.m. and an afternoon session from 12:30 to 3:30 p.m. The academic training program operates from mid-August through the end of May. The childcare school includes up to 10 students for compensation. There is a teacher, the property/business owner, and an assistant. The school starting and ending time changed since 2007 starting 30 minutes earlier and ending 30 minutes later.

The school's outdoor play area is located on the property's side yard on the east side of the home and is screened by a 6-foot high perimeter wall. The applicant is not requesting any building modifications or expansions of the property as part of this request. A fire department approved third party monitored automatic smoke detection system has been installed. The home is not located within a homeowners association.

Planning Commission and Planning Staff are recommending Use Permit approval with no time limit given this childcare school has been approved with a Use Permit since 2002 and there have been no complaints from area homeowners during this time. Commission and Staff are of the opinion that the proposed residential academic training for children business works well at this location and does not impact the surrounding neighborhood.

#### **PUBLIC/NEIGHBORHOOD NOTIFICATION**

- This request was noticed in accordance with the requirements of the Chandler Zoning Code.
- A neighborhood meeting was held on December 19, 2012. Six area neighbors representing a few homes in the area attended in support of this request.
- Staff has received phone calls and email correspondence in support.
- Staff received a phone call from an adjacent property owner to the east. The homeowner conveyed they moved in about 1 ½ years ago and has concerns with the abutting playground area, the noise from kids, and vehicular traffic in the morning and evening. The homeowner initially did not provide a name or number for Staff to follow up. The homeowner called again prior to the Commission hearing; however, Staff and the homeowner left each other voice messages.

Planning Commission and Planning Staff, upon finding consistency with the General Plan, recommend approval of the Use Permit subject to the following conditions:


1. Use Permit approval for operating residential childcare shall be applicable only to the location identified with this application and shall not be transferable to any other location.
2. The Use Permit is granted for a maximum of 10 children for compensation.
3. Expansion or modification beyond the approved exhibits (Site Plan, Floor Plan, Narrative) shall require a new Use Permit application and approval.

**RECOMMENDATION**

Move to approve Use Permit case ZUP12-0017 SHEILA'S CHRISTIAN ACADEMY "MINDS IN MOTION", subject to the conditions recommended by Planning Commission and Planning Staff.




**Vicinity Map**

**NARRATIVE STATEMENT**

I am the owner/director/ lead teacher of Sheila's Christian Academy "Minds in Motion". This business is located within my single-family home at 2735 West Highland Street in Chandler. This is a Montessori school, state licensed by DHS (Department of Health Services) since 1995.


I have had a Use Permit approved by City of Chandler for this property since May 2002 in which a 5-year Use Permit was granted. An additional five years was granted in 2007. This is my third Use Permit request. I have been running this licensed group preschool within my home for the past 17 years since 1995. I have lived in the same neighborhood/home for over 23 years.

The home is my primary residence and where the school operates. The home is approximately 2,169 livable square feet on an approximate 8,860 square foot lot. I have 10 students in my care with a qualified assistant. I am licensed up to a maximum 10 students and request Use Permit approval for a maximum of 10 students for compensation. There is a 1:5 teacher/child ratio that is required by State law. A Spanish teacher comes for an hour twice a week. My main school calendar year runs from August through May. It is open Tuesdays through Fridays 8:00 AM to 3:30 PM. I have an optional AM and PM session available although a majority of my students stay a full day. Last year, I only had three students that did not come all day. Morning sessions run from 8:00 AM to 12:00 PM and the afternoon session runs from 12:30 to 3:30 PM. I am closed during major holidays and try to follow closely with the Chandler and Tempe school district's schedule.




