Chandler Boulevard.

**DISCUSSION**

The following application for a liquor license was posted for hearing on February 28, 2013:

New License, Series 9, Liquor Store Liquor License for Clare Hollie Abel, Agent, Wal-Mart Stores Inc, dba Wal-Mart Market #2657, located at 6085 W. Chandler Boulevard.

**Consideration may be given to the applicant’s personal qualifications and to the location.**

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 9, Liquor Store Liquor License, the business may sell all alcoholic beverages for off-premise consumption only.

Transportation and Development advises a new Use Permit is not required since this will be a continuation of the location's previous use as Bashas.


