SUBJECT: NEW LICENSE SERIES 12 RESTAURANT LIQUOR LICENSE APPLICATION FOR SHELLEY DENISE EICH, AGENT, FULLER’S BAR AND GRILL LLC, DBA FULLER’S SPORTS BAR AND GRILL

RECOMMENDATION

Staff recommends Council forward a recommendation for approval of State Liquor License No. 12079450, and further, that approval be given for the City of Chandler Series 12, Restaurant Liquor License No. 147017 L12, for Shelley Denise Eich, Agent, Fuller’s Bar and Grill LLC, dba Fuller’s Sports Bar and Grill, located at 4929 W. Ray Road, Suite 3.

DISCUSSION

The following application for a liquor license was posted for hearing on May 9, 2013:

New License, Series 12, Restaurant Liquor License for Shelley Denise Eich, Agent, Fuller’s Bar and Grill LLC, dba Fuller’s Sports Bar and Grill, located at 4929 W. Ray Road, Suite 3.

Consideration may be given to the applicant’s personal qualifications and to the location.

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City’s Tax Code. With a Series 12, Restaurant Liquor License, the business may sell all liquors for on-premise consumption only, with a minimum of 40% of the gross receipts from the sale of food.

Transportation and Development advises a new Use Permit is not required since this will be a continuation of the location's previous use as Darkhorse Sports Bar & Grill.


PROPOSED MOTION

This map shows the locations of all churches, schools and spirituous liquor outlets within a one (1) mile radius of the proposed location.




