**SUBJECT:** SERIES 6 BAR LIQUOR LICENSE APPLICATION FOR  
TED WESTON SMITH, AGENT, TWS INC., DBA MAX AND TED'S 480

**RECOMMENDATION**

Staff recommends Council forward a recommendation for approval of State Liquor License No. 06070133, and further, that approval be given for the City of Chandler Series 6, Bar Liquor License No. 147114 L6, for Ted Weston Smith, Agent, TWS Inc., dba Max and Ted's 480, located at 480 N. Arizona Avenue.

**BACKGROUND**

This application reflects a change in ownership. The Transportation and Development Department advises that a new Use Permit is required for modification beyond the approved floor plan of the location's previous use as Maxted Inc. dba Max & Ted's 480.

**DISCUSSION**

The following application for a liquor license was posted for hearing on June 27, 2013, at which time it was continued until July 11, 2013:

Series 6, Bar Liquor License for Ted Weston Smith, Agent, TWS Inc., dba Max and Ted's 480, located at 480 N. Arizona Avenue.

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 6, Bar Liquor License, the business may sell all alcoholic beverages for on- or off-premise consumption.

The applicant's Use Permit through Transportation and Development is also scheduled for this meeting.


