**RECOMMENDATION**

Staff recommends Council forward a recommendation for approval of State Liquor License No. 10076419, and further, that approval be given for the City of Chandler Series 10, Beer and Wine Store Liquor License No. 43268 L10, for Randy Nations, Agent, 99 Cents Only Store #167, located at 1996 N. Alma School Road.

**DISCUSSION**

The following application for a liquor license was posted for hearing on August 15, 2013, at which time it was continued until September 12, 2013:

New License, Series 10, Beer and Wine Store Liquor License for Randy Nations, Agent, 99 Cents Only Store #167, located at 1996 N. Alma School Road.

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 10, Beer and Wine Store Liquor License, the business may sell beer and wine only for off-premise consumption.

The applicant's Use Permit through Transportation and Development is also scheduled for this meeting.


