**RECOMMENDATION**

Staff recommends Council forward a recommendation for approval of State Liquor License No. 10076424, and further, that approval be given for the City of Chandler Series 10, Beer and Wine Store Liquor License No. 105517 L10, for Clare Hollie Abel, Agent, DG Retail LLC, dba Dollar General Store #10200, located at 400 W. Ray Road.

**DISCUSSION**

The following application for a liquor license was posted for hearing on September 12, 2013, at which time it was continued until September 26, 2013:

New License, Series 10, Beer and Wine Store Liquor License for Clare Hollie Abel, Agent, DG Retail LLC, dba Dollar General Store #10200, located at 400 W. Ray Road.

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 10, Beer and Wine Store Liquor License, the business may sell beer and wine only for off-premise consumption.

The applicant's Use Permit through Transportation and Development is also scheduled for this meeting.


