SUBJECT: LUP13-0016 HOT POT CARIBBEAN CUISINE

Request: Liquor Use Permit approval to sell liquor as permitted under a Series 12 Restaurant License for on-premise consumption in a restaurant

Location: 2081 North Arizona Avenue, Suite 132, northeast corner of Arizona Avenue and Warner Road

Applicant: Karen Francis

RECOMMENDATION

Planning Commission and Planning Staff, finding consistency with the General Plan and Planned Area Development (PAD) zoning, recommend approval subject to conditions.

BACKGROUND

The subject site is located at 2081 North Arizona Avenue, Suite 132, northeast corner of Arizona Avenue and Warner Road in the Chandler Mercado shopping center. Dunkin Donuts, Golf Academy, PGA Tour Superstore, and other businesses are located in the center. The developments surrounding the Arizona Ave. and Warner Rd. intersection contain commercial and industrial related uses. Thorobred Chevrolet auto dealership is to the north.

The request is for Liquor Use Permit approval to sell liquor as permitted under a Series 12 Restaurant License for on-premise consumption in an existing restaurant.

Hot Pot Caribbean Cuisine is located in a middle suite of the western building, facing Arizona Avenue. The suite floor area is approximately 1,400 square feet and provides 19 customer seats. The business employs four staff members. Hours of operation are from 11 a.m. until 9 p.m., Monday through Thursday, and from 11 a.m. until 10 p.m. on Friday and Saturday. Background music is provided through house speakers. One television is in the dining area. No live entertainment is proposed.

A Series 12 Restaurant License allows the on-site sale of beer, wine, and spirits for on-premise consumption. Under a typical Series 12 license the establishment must derive at least 40 percent of its gross revenue from the sale of food and non-alcoholic beverages. See attached menu.

DISCUSSION

Planning Staff supports the request, finding that the restaurant is compatible with the existing retail and restaurant establishments in the Chandler Mercado shopping center. There have been no complaints filed with the Police Department or opposition during the neighborhood notification and public notification processes.

PUBLIC / NEIGHBORHOOD NOTIFICATION

- This request was noticed in accordance with the requirements of the Chandler Zoning Code.
- A neighborhood meeting was held on October 10, 2013, at the Downtown Community Center. No one other than the applicant attended.
- The Police Department has been informed of the application and has no issues or concerns.
- As of this writing, Planning Staff has not received any phone calls or letters in opposition to the request.

RECOMMENDED ACTION

Planning Commission and Planning Staff, upon finding consistency with the General Plan and Planned Area Development (PAD) zoning, recommend approval of LUP13-0016 HOT POT CARIBBEAN CUISINE, subject to the following conditions:

1. The Use Permit granted is for a Series 12 license only, and any change of license shall require reapplication and new Use Permit approval.
2. The Use Permit is non-transferable to any other location.
3. Expansion or modification beyond the approved exhibits (Site Plan, Floor Plan and Narrative) shall void the Use Permit and require a new Liquor Use Permit application and approval.


4. The site shall be maintained in a clean and orderly manner.








Railroad

Town of Gilbert




Vicinity Map

Liquor Use Permit**






Warner Rd.



