SUBJECT: REQUEST TO ADD SAMPLING PRIVILEGES FOR A SERIES 10 BEER AND WINE STORE LIQUOR LICENSE FOR ANDREA DAHLMAN LEWKOWITZ, AGENT, Y-OPCO LLC, DBA FRESH & EASY #1017

RECOMMENDATION

Staff recommends Council forward a recommendation for approval to add sampling privileges to the applied for State Liquor License No. 10076461s, and further, that approval be given to add sampling privileges to the City of Chandler Series 10, Beer and Wine Store Liquor License No. 151296 L10, for Andrea Dahlman Lewkowicz, Agent, Y-OPCO LLC, dba Fresh & Easy #1017, located at 3000 N. Alma School Road.

BACKGROUND

Y-OPCO LLC, dba Fresh & Easy #1017 has applied for a new Series 10 Beer and Wine Store Liquor License which is scheduled for this meeting. The applicant has submitted an application to add sampling privileges to their Series 10 State Liquor License No. 10076461. The Arizona State Legislature amended A.R.S. Section 4-206.01(J) effective July 29, 2010, allowing an applicant or licensee of a Liquor Store License or a Beer and Wine Store License to apply for sampling privileges.

DISCUSSION

The following application to add sampling privileges to the applied for liquor license was posted for hearing on February 13, 2014:

Series 10, Beer and Wine Store Liquor License, for Andrea Dahlman Lewkowicz, Agent, Y-OPCO LLC, dba Fresh & Easy #1017, located at 3000 N. Alma School Road.

All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 10, Beer and Wine Store Liquor License, the business may sell beer and wine only for off-premise consumption.
