SUBJECT: RESOLUTION NO. 4738 AUTHORIZING THE FIRST AMENDMENT TO THE PROJECT AGREEMENT BETWEEN THE CITY OF CHANDLER AND MARICOPA ASSOCIATION OF GOVERNMENTS (MAG) FOR THE ADVANCEMENT OF REGIONAL REIMBURSEMENT FOR THE CONSTRUCTION OF MCQUEEN ROAD (OCOTILLO ROAD TO CHANDLER HEIGHTS ROAD) IN THE AMOUNT OF \$3,895,652 TO 2013

RECOMMENDATION: Staff recommends City Council approval of Resolution No. 4738 authorizing the first amendment to the project agreement between the City of Chandler and Maricopa Association of Governments (MAG) for the advancement of regional reimbursement for the construction of McQueen Road (Ocotillo Road to Chandler Heights Road) in the amount of \$3,895,652 to 2013.

BACKGROUND AND DISCUSSION: The original project agreement is for reimbursement of Proposition 400 funds to the City of Chandler for design, right-of-way, and construction for McQueen Road (Ocotillo Road to Riggs Road). Reimbursement was originally programmed in 2017, 2018, 2019, and 2020. This project involves street widening improvements to McQueen Road (Ocotillo Road to Riggs Road).

This advancement of the reimbursement of Proposition 400 funds to 2013 is for the construction of the portion of McQueen Road from Ocotillo Road to Chandler Heights Road. These advanced Proposition 400 funds are federal Surface Transportation Program (STP) funds that required obligation of the funding in federal fiscal year 2013, which has already been completed. The construction of this project will start in the summer of 2014.

FINANCIAL IMPLICATIONS: This agreement will advance regional reimbursement to the City of Chandler for construction of McQueen Road (Ocotillo Road to Chandler Heights Road) in the amount of \$3,895,652. This first amendment advances reimbursement for the Ocotillo Road to Chandler Heights Road portion to 2013 for a revised regional reimbursement of \$3,895,652, and may be adjusted annually for inflation, in accordance with MAG policies. Because the construction of this project has been accelerated, there is no grant appropriation specific for this project in the current fiscal year. We will transfer grant appropriation authority from the Chandler Boulevard/Alma School Road intersection project. The construction was pushed back from Fiscal Year 2015 to Fiscal Year 2016 and from the Street Construction/Various Improvements Project where we carry grant appropriation for un-anticipated grants. This will allow the project to start construction this year with reimbursements starting immediately thereafter.

PROPOSED MOTION: Staff recommends City Council approval of Resolution No. 4738 authorizing the first amendment to the project agreement between the City of Chandler and Maricopa Association of Governments (MAG) for the advancement of regional reimbursement for the construction of McQueen Road (Ocotillo Road to Chandler Heights Road) in the amount of \$3,895,652 to 2013.

RESOLUTION NO. 4738

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHANDLER, ARIZONA, AUTHORIZING THE FIRST AMENDMENT TO THE PROJECT AGREEMENT BETWEEN THE CITY OF CHANDLER AND MARICOPA ASSOCIATION OF GOVERNMENTS (MAG) FOR ADVANCEMENT OF FUTURE REIMBURSEMENT TO THE CITY FOR CONSTRUCTION FOR THE MCQUEEN ROAD (OCOTILLO ROAD TO CHANDLER HEIGHTS ROAD) ARTERIAL CAPACITY IMPROVEMENT PROJECT IN THE AMOUNT OF \$3,895,652 TO 2013.

WHEREAS, the Maricopa Association of Governments ("MAG") has been designated as the regional planning agency for the Arterial Life Cycle Program portion of the Regional Transportation Plan; and

WHEREAS, the City of Chandler (the "City") and MAG have previously entered into an Arterial Life Cycle Program Project Agreement dated August 5, 2013, under which the City is programmed to receive reimbursement up to \$3,895,652 for local funds expended by the City in connection with the construction of improvements for McQueen Road (Ocotillo Road to Chandler Heights Road) pursuant to the reimbursement schedule set out in the Agreement for the improvement project; and

WHEREAS, the City and MAG desire to have the original reimbursement schedule replaced with three new schedules, each of which is applicable respectively to one of three smaller projects that compromise the larger improvement project originally described in the Agreement, but without any change to the total amount of funds allocated to the City pursuant to the Agreement;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Chandler, Arizona that the First Amendment to the Project Agreement is hereby approved, subject to the City Attorney's approval to the form of the document, and the Mayor is authorized to sign and execute said First Amendment to the Project Agreement on behalf of the City of Chandler.

FIRST AMENDMENT TO AGREEMENT

THIS FIRST AMENDMENT TO ARTERIAL LIFE CYCLE PROGRAM (ALCP) PROJECT AGREEMENT (this "First Amendment") is made and entered into effective on the day which it is executed by the MAG Executive Director (the "Effective Date"), by and between the Maricopa Association of Governments ("MAG") and the City of Chandler, an Arizona municipal corporation ("Chandler"). MAG and Phoenix are sometimes referred to in this First Amendment collectively as the "Parties" and each individually as a "Party."

RECITALS

A. The Parties entered into an Arterial Life Cycle Program Project Agreement dated August 5, 2013 (the "Original Agreement"). All capitalized terms used without definition in this Amendment shall have the definitions ascribed to them in the Original Agreement, as modified by this First Amendment.

B. The Original Agreement provided for the improvement of McQueen Road: Ocotillo Road to Riggs Road under RTP Project Number ACI-PRC-10-03-C.

C. In September of 2013, the MAG region had a balance of federal funding that needed be programmed and obligated before the end of the federal fiscal year.

D. MAG asked agencies to submit projects that were eligible for federal funding and could obligate before the end of the federal fiscal year.

E. The construction phase of the improvements on McQueen Road from Ocotillo Road to Chandler Heights met the required criteria and was submitted for consideration.

F. On September 16, 2013, the MAG Regional Council Executive committee approved Federal Fiscal Year 2013 funding for the construction phase of the improvements on McQueen Road from Ocotillo Road to Chandler Heights.

G. As such, the Parties have determined that it is in their best interest, and will best serve the purposes of the ALCP, to provide for the improvement as three individual projects with separate RTP project numbers.

H. The Parties also determined that the regional reimbursement schedule shall be amended to include the separate projects and update type of reimbursement funds and fiscal year for reimbursement based on the September 16, 2013 MAG Regional Council Executive Committee action.

I. The total amount of Allocated Regional Funds remains unchanged.

J. The Parties now desire to amend the Original Agreement upon the terms and conditions contained in this First Amendment.

AGREEMENTS

NOW, THEREFORE, for and in consideration of the foregoing Recitals and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby amend the Original Agreement as follows:

1. The title of the Original Agreement shall be replaced with the following projects:
 - a. RTP Project # ACI-PRC-10-03-C: McQueen Road: Ocotillo Road to Riggs Road (design and right-of-way only)
 - b. RTP Project # ACI-PRC-10-03-I: McQueen Road: Ocotillo Road to Chandler Heights (construction only)
 - c. RTP Project # ACI-PRC-10-03-J: McQueen Road: Chandler Heights to Riggs Road (construction only)

2. The TIP Project Numbers listed in the title of the Original Agreement shall be replaced with the following: CHN10-101DZ, CHN10-101D2Z, CHN10-101RWZ, CHN13-111CZ, CHN10-101CZ2

3. Recital G of the Original Agreement, the regional reimbursement schedule for the Project, shall be replaced with the following:
 - a. McQueen Road: Ocotillo Road to Riggs Road (design and right-of-way only)
