Consideration may be given to the applicant’s personal qualifications and to the location.


The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 13, Domestic Farm Winery License, the business may serve wine samples and sell wine produced or manufactured on the premises for consumption on or off the premises.

The applicant’s Use Permit through Transportation and Development was approved at the March 27, 2014 meeting.
