**SUBJECT:** Call of Election – Primary and General

Resolution No. 4748 designates August 26, 2014 as the date of the Primary election and November 4, 2014 as the date of the Regular (General) election for the City of Chandler in consolidation with the statewide election dates and announces the voter registration cutoff for each. The Primary election will be held for the purpose of electing a mayor and three council members. A candidate for the office of councilmember may be declared elected at the Primary election if he/she receives a majority of the votes cast for the office of mayor. If there are any offices to which no candidate was declared elected, then a runoff election will be held.

Nomination papers and petitions are currently available in the Office of the City Clerk. A candidate must file the required nomination papers and signature petitions beginning April 28, but no later than 5:00 p.m. on May 28, 2014 in order to have his or her name placed on the ballot.

In addition, the resolution authorizes the City Clerk to enter into an agreement with Maricopa County Elections Department to coordinate the administration of the elections in regards to services and fees. Once again, on-site early voting will be available at City Hall during each election period.

**PROPOSED MOTION:**

Move to adopt Resolution No. 4748 designating the 2014 Primary and General election dates and authorize the City Clerk to enter into an agreement for election services.

**RESOLUTION NO. 4748**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHANDLER, COUNTY OF MARICOPA, STATE OF ARIZONA, DESIGNATING THE 2014 CITY ELECTION DATES AND PURPOSES OF THE ELECTION; DESIGNATING THE DEADLINE FOR VOTER REGISTRATION; AND DESIGNATING THE PLACE AND DATE FOR CANDIDATES TO FILE NOMINATION PAPERS.

BE IT RESOLVED, by the Mayor and City Council of the City of Chandler as follows:

Section 1. That August 26, 2014 has been set as the time for holding the Primary election in the City of Chandler for the purpose of electing a mayor and three council members. Any candidate receiving a majority of all the votes cast for the office of mayor at the Primary election will be declared elected without running at the Regular (General) election. If a Regular election is needed, it will be held on November 4, 2014.

Section 2. The last day to register to vote is July 28, 2014 to be eligible to vote in the Primary election and October 6, 2014 to be eligible to vote in the General election.

Section 3. Candidates seeking municipal office may obtain nomination materials at the Chandler City Clerk's Office, 175 S. Arizona Avenue. Candidates may file the nomination materials beginning April 28, 2014, but no later than 5:00 p.m. on May 28, 2014.

Section 4. The City Clerk is authorized to enter into an agreement with Maricopa County Elections Department for the administration of the election and payment of fees for services.
