**RECOMMENDATION**

Staff recommends Council forward a recommendation for approval of State Liquor License No. 12079805, and further, that approval be given for the City of Chandler Series 12, Restaurant Liquor License No. 150879 L12, for Dominic Sarkar, Agent, Nasha Lounge & Bar LLC, dba Nasha Lounge & Bar, located at 2051 W. Warner Road, Suite 7.

**DISCUSSION**

The following application for a liquor license was posted for hearing on April 10, 2014, at which time it was continued until May 22, 2014:

New License, Series 12, Restaurant Liquor License for Dominic Sarkar, Agent, Nasha Lounge & Bar LLC, dba Nasha Lounge & Bar, located at 2051 W. Warner Road, Suite 7.

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 12, Restaurant Liquor License, the business may sell all liquors for on-premise consumption only, with a minimum of 40% of the gross receipts from the sale of food.

Transportation and Development advises a new Use Permit is not required since this will be a continuation of the location's previous use as Nasha Indian Cuisine.


