**5. SUBJECT:** Amendment No. 1 to Agreement No. WW2-962-3128 with Cleanview Video Inspections, LLC, for Video Inspection of Sewer Lines.

**6. RECOMMENDATION:** Staff recommends City Council approval of Amendment No. 1 to Agreement No. WW2-962-3128 with Cleanview Video Inspections, LLC, for Video Inspection of Sewer Lines, for a two-year period, in a total amount not to exceed \$344,000.

**7. BACKGROUND/DISCUSSION:** The City of Chandler has approximately 868 miles of sewer lines. Sewer lines deteriorate as they age from corrosion caused by sewer gas. Once the video inspections are completed, Wastewater Collection Staff will inspect older sewer lines, detect potential problems, and make necessary repairs. These video inspections are important to complete prior to street overlays. Additionally, Maricopa County requires videotaping of all new sanitary sewer lines. This Agreement will provide for video inspections of new and existing sewer lines.

**8. EVALUATION PROCESS:** On July 26, 2012, City Council awarded Agreement No. WW2-962-3128 for Video Inspection of Sewer Lines to Cleanview Sewer Inspections, LLC. The agreement was awarded for a two-year term ending August 31, 2014, with provisions to extend for an additional two-year period. The contractor has agreed to extend the agreement with no price increases. Staff has been satisfied with the service and recommends extending the agreement.

The term of this amendment will be September 1, 2014, through August 31, 2016. This is the first and final two-year extension of the agreement.
