**RECOMMENDATION**

Staff recommends Council forward a recommendation for approval of State Liquor License No. 2079898, and further, that approval be given for the City of Chandler Series 12, Restaurant Liquor License No. 152927 L12, for Jared Michael Repinski, Agent, Pizza on 87 LLC, dba Pizza on 87, located at 1368 N. Arizona Avenue, Suite 101.

**DISCUSSION**

The following application for a liquor license was posted for hearing on June 12, 2014:

New License, Series 12, Restaurant Liquor License for Jared Michael Repinski, Agent, Pizza on 87 LLC, dba Pizza on 87, located at 1368 N. Arizona Avenue, Suite 101.

**Consideration may be given to the applicant’s personal qualifications and to the location.**

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 12, Restaurant Liquor License, the business may sell all liquors for on-premise consumption only, with a minimum of 40% of the gross receipts from the sale of food.

The applicant’s Use Permit through Transportation and Development was approved on May 8, 2014.



This map shows the locations of all churches, schools and spirituous liquor outlets within a one (1) mile radius of the proposed location.


