RECOMMENDATION

Staff recommends approval of the FY 2014-15 annual dues to the League of Arizona Cities and Towns in the amount of \$88,250.00.

BACKGROUND

The City of Chandler is an active member of the League of Arizona Cities and Towns. Each year we are assessed annual dues that are based on a per capita formula and minimum base fee. For cities with populations over 200,000, the dues for FY 2014-15 are capped at \$88,250.00. This is the third consecutive year that dues have been capped at this amount.

DISCUSSION

The League works closely with the City's Intergovernmental Affairs Coordinator in providing legislative and lobbyist assistance to its member cities. When the issue is of statewide concern, the League will take the lead position, freeing up the time for the City's Intergovernmental Affairs Coordinator to focus on issues of concern to our citizenry. As has been evidenced, this assistance is critical during the legislative session and allows for cities to work together on issues of regional and municipal interest.

FINANCIAL IMPLICATIONS

Funding for the annual dues payment is available in FY 2014-15 General Fund, Non-Departmental, Subscriptions and Memberships, Account No. 101.1290.5810.

PROPOSED MOTION

Move to authorize the payment of FY 2014-15 membership dues to the League of Arizona Cities and Towns in the amount of \$88,250.00.
