5. SUBJECT: Police Uniforms

6. RECOMMENDATION: Recommend approval of Amendment #3 to extend Agreement #PD1-200-2954 with Skaggs East Valley Uniforms, Inc. for the purchase of Police uniforms for a new total contract amount not to exceed \$160,000.

7. HISTORICAL BACKGROUND/DISCUSSION: This contract supplies the Police Department's annual need for uniforms for all patrol officers (including reserves), motor officers, park rangers, detention officers, ID techs, Explorers, motorist assist volunteers, as well as some uniform related accessories such as baseball caps and Class A hats. This contract also allows for replacement of worn or damaged uniforms, alterations, etc. The approved contract amount of \$100,000 has been exceeded by the allowed 10% (\$10,000). Because an additional \$50,000 is needed to provide personnel with necessary uniforms, Council approval is now necessary and will bring the new total contract amount to \$160,000.


8. EVALUATION PROCESS: In August 2011, Council awarded Agreement #PD1-200-2954 to East Valley Uniforms for the purchase of Police uniforms. East Valley Uniforms has since been purchased by Skaggs Uniforms and is now Skaggs East Valley Uniforms. The contract has been extended for the last two years and a 90-day extension of the contract is being requested to ensure the supply of uniforms for Police personnel while a new solicitation process is conducted. Skaggs East Valley Uniforms has agreed to extend the contract for 90 days with no price increases.

9. FINANCIAL IMPLICATIONS: Funds for Police uniforms will be from General Fund, Field Operations, Clothing and Uniform account 101.2030.5313.





NOW THEREFORE, the parties agree as follows:


1. This contract is extended for a ninety-day period, September 1, 2014 through December 31, 2014.


