SUBJECT: LUP14-0013 HYATT PLACE PHOENIX/CHANDLER FASHION CENTER

Request: Liquor Use Permit approval to sell and serve liquor as permitted under a Series 11 (Hotel License) for on-premises consumption of beer, wine, and spirits

Location: 3535 W. Chandler Boulevard, southwest corner of Chandler Boulevard and Chandler Village Drive

Applicant: Andrea Lewkowitz/Lewkowitz Law Office, PLC

RECOMMENDATION

Upon finding the request to be consistent with the General Plan, Planning Commission and Planning Staff recommend approval subject to conditions.

BACKGROUND

This property is undergoing renovation from Windmill Suites to a Hyatt Place hotel. The former hotel did not serve liquor. Hyatt Place hotel will offer food and beverage service including alcoholic beverages. The Series 11 (Hotel License) allows for on-premises consumption of beer, wine, and spirits. The hotel will serve alcoholic beverages in the gallery market, kitchen and dining area, and at the bar. Hyatt Place is a 3-story hotel at approximately 93,000 square feet and 130 guest rooms.

The restaurant on the licensed premises must derive at least forty percent (40%) of its gross revenue from the sale of food. The holder of this license may sell spirituous liquor in sealed containers in individual portions to its registered guests at any time by means of a minibar located in the guest rooms of registered guests.

PUBLIC / NEIGHBORHOOD NOTIFICATION

- The request was noticed in accordance with the requirements of the Chandler Zoning Code.
- The applicant's neighborhood meeting was held on July 24, 2014. No one attended other than the applicant.
- At the time of the memo, Planning Staff is not aware of any concerns or opposition to this request.

RECOMMENDED ACTION

Planning Commission and Planning Staff, upon finding consistency with the General Plan, recommend approval of Liquor Use Permit LUP14-0013 HYATT PLACE PHOENIX/CHANDLER FASHION CENTER, subject to the following conditions:


1. Expansion, modification, or relocation beyond the approved exhibits (Site Plan, Floor Plan, and Narrative) shall void the Liquor Use Permit and require new Liquor Use Permit re-application and approval.
2. The Liquor Use Permit is granted for a Series 11 (Hotel License) only, and any change of licenses shall require re-application and new Liquor Use Permit approval.
3. The Liquor Use Permit is non-transferable to other store locations.
4. The site shall be maintained in a clean and orderly manner.

PROPOSED MOTION

Move to approve Liquor Use Permit case LUP14-0013 HYATT PLACE PHOENIX/CHANDLER FASHION CENTER, subject to the conditions recommended by Planning Commission and Planning Staff.





Hyatt Place Phoenix/Chandler-Fashion Center will take over the hotel currently operated as the Windmill Suites of Chandler at 3535 W. Chandler Blvd. in September 2014. The Hyatt Place concept combines style, innovation, and modern convenience to guests.

Hyatt Place will offer food and beverage service at the 24/7 Gallery and Market, the "A.M. Kitchen Skillet" (buffet breakfast), and the Coffee to Cocktail Bar. The hotel intends to apply for a series II liquor license to allow guests 21 and over the opportunity to purchase alcoholic beverages for consumption on the premises. Series II licenses allow sales/service of beer, wine and spirits; 40% of all food and beverage sales must come from the sale of food. Although food service will be available 24 hours per day, alcoholic beverages will be available only during legal hours (currently 6 am – 2 am).

The three-story hotel has 93,376 square feet of interior space, including 129 guestrooms, public spaces, meeting rooms, and dining areas. The outdoor courtyard includes approximately 7,500 square feet of gardens and a swimming pool.

The hotel will employ approximately 12 full and part time employees for its food and beverage service. There will not be outdoor alcohol service, but guests may take a drink (in plastic) to the garden and pool areas. All employees involved in the sale and service of alcohol will complete Training for Intervention Procedures (TIPS) for responsible alcohol sales and service. There will not be any live or recorded music, pool tables, games, or dancing, but there will be three televisions in the dining areas.





