**SUBJECT:** PERMANENT EXTENSION OF PREMISES SERIES 12 RESTAURANT LIQUOR LICENSE HELD BY GOGI INC., DBA GOGI

**RECOMMENDATION**

Staff recommends Council forward a recommendation for approval of a permanent extension of premises for State Liquor License No. 12079654, a Series 12, Restaurant Liquor License, held by Gogi Inc., dba GOGI, located at 2095 N. Dobson Road, Suite C-8, and further, that approval be given for the permanent extension to the City of Chandler Liquor License No. 148241 L12.

**BACKGROUND**

Gogi Inc., dba GOGI, located at 2095 N. Dobson Road, Suite C-8, has requested a permanent extension of their alcohol serving area to include outside seating. This business was approved for a Series 12, Restaurant Liquor License on December 12, 2013.

The Police Department has no objections to the permanent extension of premises. All fees have been paid and the business is in compliance with the City's Tax Code.



The applicant's Use Permit through Transportation and Development was approved at the Council meeting on December 12, 2013.





