SUBJECT: REQUEST TO ADD SAMPLING PRIVILEGES FOR A SERIES 9 LIQUOR STORE LIQUOR LICENSE FOR CLARE HOLLIE ABEL, AGENT, WALMART STORES INC., DBA WAL-MART SUPERCENTER #2671

RECOMMENDATION

Staff recommends Council forward a recommendation for approval to add sampling privileges to the existing State Liquor License No. 09070352s, and further, that approval be given to add sampling privileges to the City of Chandler Series 9, Liquor Store Liquor License No. 100664 L9, for Clare Hollie Abel, Agent, Walmart Stores Inc., dba Wal-Mart Supercenter #2671, located at 1175 S. Arizona Avenue.

BACKGROUND

Walmart Stores Inc., dba Wal-Mart Supercenter #2671 has been in business at this location since May 25, 2005 at which time Council approved a Series 9, Liquor Store Liquor License. The applicant has submitted an application to add sampling privileges to their Series 9, State Liquor License No. 09070352. The Arizona State Legislature amended A.R.S. Section 4-206.01(J) effective July 29, 2010, allowing an applicant or licensee of a Liquor Store License to apply for sampling privileges.

DISCUSSION

The following application to add sampling privileges to the existing liquor license was posted for hearing on December 11, 2014:

Series 9, Liquor Store Liquor License, for Clare Hollie Abel, Agent, Walmart Stores Inc., dba Wal-Mart Supercenter #2671, located at 1175 S. Arizona Avenue.

All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 9, Liquor Store Liquor License, the business may sell all alcoholic beverages for off-premise consumption only.

PROPOSED MOTION

Move for recommendation to the State Department of Liquor Licenses and Control for approval to add sampling privileges to the existing State Liquor License No.09070352s, for Walmart Stores Inc., dba Wal-Mart Supercenter #2671, located at 1175 S. Arizona Avenue, and approval to add sampling privileges to the City of Chandler Liquor License.
