**SUBJECT:** PERMANENT EXTENSION OF PREMISES SERIES 12 RESTAURANT LIQUOR LICENSE HELD BY BAY LEAF LLC, DBA BAY LEAF CAFÉ INDIA CUISINE

**RECOMMENDATION**

Staff recommends Council forward a recommendation for approval of a permanent extension of premises for State Liquor License No. 12079191, a Series 12, Restaurant Liquor License, held by Bay Leaf LLC, dba Bay Leaf Café India Cuisine, located at 955 W. Chandler Heights Road, Suite 1, and further, that approval be given for the permanent extension to the City of Chandler Liquor License No. 139167 L12.

**BACKGROUND**

Bay Leaf LLC, dba Bay Leaf Café India Cuisine, located at 955 W. Chandler Heights Road, Suite 1, has requested a permanent extension of their alcohol serving area to include outside seating. This business was approved for a Series 12, Restaurant Bar Liquor License on September 27, 2012.


The Police Department has no objections to the permanent extension of premises. All fees have been paid and the business is in compliance with the City's Tax Code.

The applicant's Use Permit through Transportation and Development was approved on January 22, 2015.


