RECOMMENDATION

Staff recommends Council forward a recommendation for approval of State Liquor License No. 06070018, and further, that approval be given for the City of Chandler Series 6, Bar Liquor License No. 157467 L6, for Amy S. Nations, Agent, Stapleton Entertainment LLC, dba Dirty Blonde Tavern, located at 4929 W. Chandler Boulevard, Suite 12.

DISCUSSION

The following application for a liquor license was posted for hearing on March 26, 2015, at which time it was continued until April 30, 2015:

New License, Series 6, Bar Liquor License for Amy S. Nations, Agent, Stapleton Entertainment LLC, dba Dirty Blonde Tavern, located at 4929 W. Chandler Boulevard, Suite 12.

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 6, Bar Liquor License, the business may sell all alcoholic beverages for on- or off-premise consumption.

The applicant's Use Permit through Transportation and Development is also scheduled for this meeting.



