RECOMMENDATION

Staff recommends Council forward a recommendation for approval of State Liquor License No. 120714120, and further, that approval be given for the City of Chandler Series 12, Restaurant Liquor License No. 156536 L12, for Arvinder Kaur, Agent, Chennai Fusion Café LLC, dba Chennai Fusion Grill, located at 4929 W. Chandler Boulevard, Suite 1.

DISCUSSION

The following application for a liquor license was posted for hearing on February 26, 2015, at which time it was continued until April 30, 2015:

New License, Series 12, Restaurant Liquor License for Arvinder Kaur, Agent, Chennai Fusion Café LLC, dba Chennai Fusion Grill, located at 4929 W. Chandler Boulevard, Suite 1.

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 12, Restaurant Liquor License, the business may sell all liquors for on-premise consumption only, with a minimum of 40% of the gross receipts from the sale of food.

The applicant's Use Permit through Transportation and Development is also scheduled for this meeting.


PROPOSED MOTION

This map shows the locations of all churches, schools and spirituous liquor outlets within a one (1) mile radius of the proposed location.


