SUBJECT: REQUEST TO ADD SAMPLING PRIVILEGES FOR A SERIES 9 LIQUOR STORE LIQUOR LICENSE FOR CLARE HOLLIE ABEL, AGENT, WAL-MART SUPERCENTER #3360

RECOMMENDATION

Staff recommends Council forward a recommendation for approval to add sampling privileges to the existing State Liquor License No. 09070686s, and further, that approval be given to add sampling privileges to the City of Chandler Series 9, Liquor Store Liquor License No. 101751 L9, for Clare Hollie Abel, Agent, Wal-Mart Supercenter #3360, located at 2750 E. Germann Road.

BACKGROUND

Wal-Mart Supercenter #3360 has been in business at this location since August 29, 2005, at which time Council approved a Series 9, Liquor Store Liquor License. The applicant has submitted an application to add sampling privileges to their Series 9 State Liquor License No. 09070686. The Arizona State Legislature amended A.R.S. Section 4-206.01(J) effective July 29, 2010, allowing an applicant or licensee of a Liquor Store License or a Beer and Wine Store License to apply for sampling privileges.

DISCUSSION

The following application to add sampling privileges to the existing liquor license was posted for hearing on September 24, 2015:


Series 9, Liquor Store Liquor License, for Clare Hollie Abel, Agent, Wal-Mart Supercenter #3360, located at 2750 E. Germann Road.

All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 9, Liquor Store Liquor License, the business may sell all alcoholic beverages for off-premise consumption only.

PROPOSED MOTION

Move for recommendation to the State Department of Liquor Licenses and Control for approval to add sampling privileges to the existing State Liquor License No. 09070686s, for Clare Hollie Abel, Agent, Wal-Mart Supercenter #3360, located at 2750 E. Germann Road, and approval to add sampling privileges to the City of Chandler Liquor License.
