**SUBJECT:** RESOLUTION NO. 4887 AUTHORIZING THE PROVISIONS OF AN AGREEMENT BETWEEN THE FEDERAL GOVERNMENT AND THE CITY OF CHANDLER FOR PROVISION OF OVERTIME REIMBURSEMENTS FOR ONGOING INVESTIGATIONS

**RECOMMENDATION:** Staff recommends City Council adopt Resolution No. 4897 authorizing the provisions of an Agreement between the Federal Government and the City of Chandler for provision of overtime reimbursement for ongoing investigations.

**DISCUSSION:** The Police Department has been awarded funding for reimbursement of overtime incurred during the Department's cooperation with federal programs (Organized Crime Drug Enforcement Task Forces Program). These are one-time funds, and the amount is currently \$25,000.

**FINANCIAL IMPLICATIONS:** This grant covers overtime only for participating officers up to a total of \$25,000. The department would cover the overtime benefits.

**PROPOSED MOTION:** Move to adopt Resolution No. 4887 authorizing the provisions of an Agreement between the Federal Government and the City of Chandler for provision of overtime reimbursement for ongoing investigations.
