RECOMMENDATION

Staff recommends Council forward a recommendation for approval of the State Wine Festival/Wine Fair License 13133032, and further, that approval be given for the City of Chandler Wine Festival/Wine Fair License for Mitchelle D Levy, Agent, Burning Tree Cellars LLC, dba Burning Tree Cellars, located at Crowne Plaza San Marcos Golf Resort, 1 N. San Marcos Place.

DISCUSSION

An application for a Wine Festival/Wine Fair License has been submitted by Burning Tree Cellars LLC, dba Burning Tree Cellars for The Grand Wine Festival on Saturday, November 21, 2015, from 10:00 a.m. until 10:00 p.m. and Sunday, November 22, 2015, from 10:00 a.m. until 6:00 p.m, located at Crowne Plaza San Marcos Golf Resort, 1 N. San Marcos Place.

With a Wine Festival License, a licensed domestic farm winery, within the confines of the event during the designated event periods, can serve samples of its products, sell such products for consumption on the premises and sell their products in original containers for consumption off the premises.

The Police Department has no objections to this event, and the applicant has applied for a Temporary Sales and Promotional Event Permit through Community and Neighborhood Services.


