SUBJECT: REQUEST TO ADD SAMPLING PRIVILEGES FOR A SERIES 10 BEER AND WINE STORE LIQUOR LICENSE FOR RANDY D. NATIONS, AGENT, SF MARKETS LLC, DBA SPROUTS FARMERS MARKET #33

RECOMMENDATION

Staff recommends Council forward a recommendation for approval to add sampling privileges to the existing State Liquor License No. 10076704s, and further, that approval be given to add sampling privileges to the City of Chandler Series 10, Beer and Wine Store Liquor License No. 160351 L10, for Randy D. Nations, Agent, SF Markets LLC, dba Sprouts Farmers Market #33, located at 4065 S. Gilbert Road.

BACKGROUND

SF Markets LLC, dba Sprouts Farmers Market #33 application for a New License Series 10, Beer and Wine Store Liquor License is also scheduled for this meeting. The applicant has submitted an application to add sampling privileges to their Series 10 State Liquor License No. 10076704. The Arizona State Legislature amended A.R.S. Section 4-206.01(J) effective July 29, 2010, allowing an applicant or licensee of a Liquor Store License or a Beer and Wine Store License to apply for sampling privileges.

DISCUSSION


The following application to add sampling privileges to the existing liquor license was posted for hearing on November 19, 2015:

Series 10, Beer and Wine Store Liquor License, for Randy D. Nations, Agent, SF Markets LLC, dba Sprouts Farmers Market #33, located at 4065 S. Gilbert Road.

All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 10, Beer and Wine Store Liquor License, the business may sell beer and wine only for off-premise consumption.

PROPOSED MOTION

Move for recommendation to the State Department of Liquor Licenses and Control for approval to add sampling privileges to the existing State Liquor License No. 10076704s, for Randy D. Nations, Agent, SF Markets LLC, dba Sprouts Farmers Market #33, located at 4065 S. Gilbert Road, and approval to add sampling privileges to the City of Chandler Liquor License.
