RECOMMENDATION

Staff recommends Council forward a recommendation for approval of State Liquor License No. 10076724, and further, that approval be given for the City of Chandler Series 10, Beer and Wine Store Liquor License No. 159823 L10, for John Robert Finn, Agent, Vinum 55 Chandler LLC, dba Vinum 55 Chandler, located at 2577 W. Queen Creek Road, Suite 112.

DISCUSSION

The following application for a liquor license was posted for hearing on February 11, 2016:

New License, Series 10, Beer and Wine Store Liquor License, for John Robert Finn, Agent, Vinum 55 Chandler LLC, dba Vinum 55 Chandler, located at 2577 W. Queen Creek Road, Suite 112.

Consideration may be given to the applicant’s personal qualifications and to the location.

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 10, Beer and Wine Store Liquor License, the business may sell beer and wine only for off-premise consumption.

The applicant's Use Permit through the Planning Division was approved at the November 19, 2015, Council meeting.


PROPOSED MOTION
