SUBJECT: NEW LICENSE SERIES 6 BAR LIQUOR LICENSE APPLICATION FOR BRAD INGARFIELD, AGENT, FIELD RESTAURANT CONCEPTS LLC, DBA MURPHY'S LAW IRISH PUB & ALE HOUSE

RECOMMENDATION

Staff recommends Council forward a recommendation for approval of State Liquor License No. 06070685, and further, that approval be given for the City of Chandler Series 6, Bar Liquor License No. 161607 L6, for Brad Ingarfield, Agent, Field Restaurant Concepts LLC, dba Murphy's Law Irish Pub & Ale House, located at 58 S. San Marcos Place.

BACKGROUND

This application reflects a change in ownership. The Planning Division advises that a new Use Permit is not required since this will be a continuation of the location's previous use as Murphy's Law 58 LLC, dba Murphy's Law Irish Pub & Ale House.

DISCUSSION

The following application for a liquor license was posted for hearing on March 17, 2016:

New License, Series 6, Bar Liquor License, for Brad Ingarfield, Agent, Field Restaurant Concepts LLC, dba Murphy's Law Irish Pub & Ale House, located at 58 S. San Marcos Place.


Consideration may be given to the applicant's personal qualifications and to the location.

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 6, Bar Liquor License, the business may sell all alcoholic beverages for on- or off-premise consumption.

This map shows the locations of all churches, schools and spirituous liquor outlets within a one (1) mile radius of the proposed location.


