**5. SUBJECT:** Amendment No. 1 to Contract No. SW4-910-3378 for City Facilities Refuse Collection

**6. RECOMMENDATION:** Staff recommends City Council approve Amendment No. 1 to Contract No. SW4-910-3378, with Allied Waste Transportation, Inc., dba Republic Services of Phoenix, for City Facilities Refuse Collection, for a two-year term, in an amount not to exceed \$165,000.

**7. BACKGROUND/DISCUSSION:** The City provides refuse collection services to all City of Chandler facilities including City parks and City office buildings. In an effort to reduce the cost associated with refuse collection, Solid Waste Services converted many City facilities to a lower cost contract that provides for side-load collection of 300-gallon refuse containers.

Due to concerns for volume of waste generated, space restraints with revetments and/or parking, and access to containers for collection, the option of converting to 300-gallon container collection at some facilities was not viable. City facilities not serviced with 300-gallon container collection require front-load collection of two, three, four, and six cubic yard containers that are serviced under this contract.

**8. EVALUATION PROCESS:** On July 10, 2014, City Council approved Contract No. SW4-910-3378 with Allied Waste Transportation, Inc., dba Republic Services of Phoenix, for City Facilities Refuse Collection, for a two-year term, with the option of two (2) additional two-year extensions. The contractor has agreed to extend for the first two-year extension at the same terms, conditions, and pricing. Staff recommends extension of this contract for the term of August 1, 2016, through July 31, 2018.

1. Section 5, this Contract is extended for a two-year period, August 1, 2016 through July 31, 2018.
2. Section 4.1 Price, City shall pay Contractor the per-unit cost as set forth in Exhibit C, attached to the Agreement and made a part hereof by reference in an amount not to Exceed One hundred and sixty-five thousand dollars (\$165,000) for the two year term.
3. All other terms and conditions of the above referenced Contract shall remain unchanged and in full force and effect. All terms and conditions in the original Contract not specifically amended herein shall be incorporated by reference in its entirety and shall remain in full force and effect.
