**RECOMMENDATION**

Staff recommends Council forward a recommendation for approval of the State Craft Distillery Fair/Festival License 18103003, and further, that approval be given for the City of Chandler Craft Distillery Fair/Festival License for Chris Dudding, Agent, Three Wells Distilling Corporation dba Three Wells Distilling Company, located at Downtown Ocotillo, 2475 W. Queen Creek Road.

**DISCUSSION**

An application for a State Craft Distillery Fair/Festival License has been submitted by Three Wells Distilling Corporation dba Three Wells Distilling Company for the Chandler Craft Spirits Festival on Saturday, April 30, 2016, from 4:00 p.m. until 9:00 p.m., located at Downtown Ocotillo, 2475 W. Queen Creek Road.

With a Craft Distillery Fair/Festival License, a licensed in-state or out-of-state craft distillery, within the confines of the event during the designated event periods, can sell one liter bottles of its products, and sell such products in original containers for off premises consumption only.

The Police Department reports no objections to the issuance of this license and the festival fees have been paid.
