SUBJECT: NEW LICENSE SERIES 10 BEER AND WINE STORE LIQUOR LICENSE APPLICATION FOR KIM KENNETH KWIATKOWSKI, AGENT, CIRCLE K STORES INC., DBA CIRCLE K STORE #3490

RECOMMENDATION

Staff recommends Council forward a recommendation for approval of State Liquor License No.10076725, and further, that approval be given for the City of Chandler Series 10, Beer and Wine Store Liquor License No. 161807 L10, for Kim Kenneth Kwiatkowski, Agent, Circle K Stores Inc., dba Circle K Store #3490, located at 3087 S. McQueen Road.

DISCUSSION

The following application for a liquor license was posted for hearing on April 14, 2016, at which time it was continued until May 12, 2016:

New License, Series 10, Beer and Wine Store Liquor License for Kim Kenneth Kwiatkowski, Agent, Circle K Stores Inc., dba Circle K Store #3490, located at 3087 S. McQueen Road.

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 10, Beer and Wine Store Liquor License, the business may sell beer and wine only for off-premise consumption.


The applicant's Use Permit through the Planning Division is also scheduled for this meeting.
