**RECOMMENDATION**

Staff recommends Council forward a recommendation for approval of State Liquor License No. 07070235, and further, that approval be given for the City of Chandler Series 7, Beer and Wine Bar Liquor License No. 161620 L7, for Lauren Kay Merrett, Agent, Smith's Food & Drug Centers Inc., dba Fry's Marketplace #681, located at 2929 E. Ocotillo Road.

**DISCUSSION**

The following application for a liquor license was posted for hearing on May 12, 2016, at which time it was continued until May 26, 2016:

New License, Series 7, Beer and Wine Bar Liquor License for Lauren Kay Merrett, Agent, Smith's Food & Drug Centers Inc., dba Fry's Marketplace #681, located at 2929 E. Ocotillo Road.

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 7, Beer and Wine Bar Liquor License, the business may sell beer and wine only for on- or off-premise consumption.

The applicant's Use Permit through the Planning Division is also scheduled for this meeting.




