5. SUBJECT: Amendment No. 1 to Agreement No. CM4-840-3368 for Closed Circuit Television (CCTV) and Video Cameras

6. RECOMMENDATION: Staff recommends City Council approve Amendment No. 1 to Agreement No. CM4-840-3368, with ASSI Security of Arizona, for Closed Circuit Television (CCTV) and Video Camera's: Maintenance, Repair & Purchase, for a one-year term of July 1, 2016, through June 30, 2017, in an amount not to exceed \$100,000.

7. BACKGROUND/DISCUSSION: Security cameras are used around the City in various capacities to monitor City facilities. This agreement provides maintenance and repair on the existing infrastructure equipment as well as the purchase and installation of new hardware. Building and Facilities has budgeted \$35,000 for repairs and maintenance for security cameras at City Hall and at various other City buildings. Municipal Utilities has budgeted \$25,000 and the Police Department \$40,000 for the on-going repair and maintenance of existing security cameras along with the addition of new equipment where necessary.

8. EVALUATION PROCESS: On June 12, 2014, City Council approved an agreement with ASSI Security of Arizona for CCTV and video cameras for a two-year period with the option of up to three one-year extensions. ASSI Security of Arizona has agreed to extend for one additional year at the same terms, conditions and pricing.

Staff recommends extension of this agreement for a one-year term of July 1, 2016, through June 30, 2017. This is the first extension of the agreement.
