RECOMMENDATION

Staff recommends Council forward a recommendation for approval of State Liquor License No. 07070707, and further, that approval be given for the City of Chandler Series 7, Beer and Wine Bar Liquor License No. 162580 L7, for Theresa June Morse, Agent, E-Z Enterprises Ocotillo LLC, dba The Casual Pint, located at 1095 W. Queen Creek Road, Suite 8.

DISCUSSION

The following application for a liquor license was posted for hearing on April 14, 2016, at which time it was continued until May 26, 2016, where it was further continued until June 23, 2016:

New License, Series 7, Beer and Wine Bar Liquor License for Theresa June Morse, Agent, E-Z Enterprises Ocotillo LLC, dba The Casual Pint, located at 1095 W. Queen Creek Road, Suite 8.


The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 7, Beer and Wine Bar Liquor License, the business may sell beer and wine only for on- or off-premise consumption.

The applicant's Use Permit through the Planning Division is also scheduled for this meeting.
